<b>Admission Fee</b>	<b>Rs. 50,000/- (Rs. Fifty thousand only)</b> One time payment at the time of admission, <b>Non Refundable</b>
<b>Security Deposit</b>	<b>Rs. 10,000/- (Rs. Ten thousand only)</b> One time payment at the time of admission, <b>Refundable</b>
<b>Registration Charges</b>	<b>Rs. 3,500/- (Rs. Thirty five hundred only)</b> One time payment at the time of admission, <b>Non Refundable</b>
<b>Session Fee</b> Including Tuition fee, Annual Charges, Food Charges, Field Trips, Enrichment Events and Celebrations	<b>Rs. 1,42,500/-</b> <b>(Rs. One lakh forty two thousand five hundred only)</b> <b>This does not include Transport charges which is optional.</b>
<b>Payment Schedule</b>	
<b>Payment to be made at the time of admission</b> (First Instalment of Session Fee: Rs. 60,000/- + Admission fee + Security Deposit + Registration Charges)	Rs. 1,23,500/- (Rs. One lakh twenty three thousand five hundred only)
<b>Second Instalment   July 2024</b>	Rs. 50,000/- (Rs. Fifty thousand only)
<b>Third Instalment   November 2024</b>	Rs. 32,500/- (Rs. Thirty two thousand five hundred only)
<b>Transport Charges</b>	
<b>Rs. 35,000/- (Rs. Thirty five thousand only) for the whole session irrespective of distance.</b> Subject to revision due to increase in fuel charges or imposition of any tax. Payable as follows:	
<b>First Instalment (of Transport Charges)   July 2024</b>	Rs. 18,500/- (Rs. Eighteen thousand five hundred only)
<b>Second Instalment (of Transport Charges)   Nov. 2024</b>	Rs. 16,500/- (Rs. Sixteen thousand five hundred only)
<b>Transportation Charges for Ujjain- Rs. 41,000/- per year</b>	
<b>Late Fee</b>	Rs. 30/- per day will be charged after the due date

1. Transport facility is chargeable and optional.
2. Transport facility is extended only from and to the residential address as mentioned in the application form. In case of address change, this facility will be provided only in existing routes subject to availability of room in the vehicle plying on the route.
3. We do not guarantee that every child will be picked up from and dropped off at the doorstep.
4. GST, if levied on any of the fee/facility charges, will have to be paid by the parents.
5. Generally, fee/facility charges are revised upwards by approximately 5% to 10% every year as per need.
6. In case of withdrawal after confirmed admission, only first installment of Term fee and security deposit will be refunded. Admission fee will not be refunded in any case.
7. Imprest Money of Rs. 7000/- will be payable along with the 2nd installment, before July 15, 2024. An imprest is a cash amount that an institution relies on to pay for small, routine expenses on behalf of students. Funds contained in imprest are regularly replenished in order to maintain a desired balance. The term imprest refers to a monetary advance given to the institution for defined purposes like competitive exams and activities, local excursion, rent for costumes, price of books bought from the book fete, participation charges in adventure camp, etc. Statement of account for imprest money of your ward can be obtained from the accounts department on request. Unused imprest amount will be refunded at the time of graduation or withdrawal.
